Work Summary: 5/16/2018 - 6/26/2018


Set CICR at 6320', squeezed existing perms (6376' - 6390') with 270 sx (319 cf) of Class "G" cement. Drill out squeeze job and pressure test casing to 540 psi for 30 min - held OK. Test witnessed by Sterling with Navajo Nation Minerals Department. Drill out shoe track and new formation to 6465'. TOH. PU 4-3/4" air hammer and TIH. Unload hole w/ air and continue drilling new formation w/ air hammer to 6685' (TD). Run 3-1/2" liner to 6673', TOL at 6403'. Left liner un-cemented. Perforate Mississippian formation 6626' - 6663', 4 spf, total of 150 shots. Left ~ firing head and ~ 130' of wireline in 3-1/2" after perforating. Ran 5-1/2" packer on 2-3/8" tubing. Set packer at 6395' and landed tubing in wellhead. Currently flow testing the well for helium production. Gas samples show content to be fully inert, 7.4% He and 91.5% N2.
