Plug & Abandonment Procedure:

Currently the well is producing out 1-1/4" IJ production tubing, which will need to be laid down prior to pumping cement.

1. **Plug #1, surface to 628' (Pictured Cliffs is Open Hole f' 581' – 628')**: Load hole w/ water and establish injection rate into perforations. Bullhead cement directly down 3-1/2" casing as follows: Mix & pump ~ 45 sxs (53.1 cf) of Class B cement (or equivalent). SD pump and if cement falls. Hesitate 30 min then continue pumping cement and top off as necessary. ND BOP and cut off wellhead below surface casing flange per regulation. Install P&A marker with cement to comply with regulations. Note: Due to location being in NAPI field, plan to set top of marker 6' – 8' below ground level. RD, MOL and remove pipeline and any related equipment as per NAPI/BLM/NMOCD stipulations.
