Reference is made to your Application for Permit to Drill (APD) for San Juan 27-4 Unit, 102P, # 30-039-31103, located 927' FNL & 985' FWL, Section 33, T. 27 N., R. 4 W., Rio Arriba County, New Mexico.

Per Onshore Order 1.III.G.1, an APD approval is valid for 2 years from the date it is approved, or until lease expiration, whichever occurs first. If the operator submits a written request before the expiration of the original approval, the Bureau of Land Management, may extend the APD's validity for up to two (2) additional years. 2. The operator is responsible for reclaiming any surface disturbance that resulted from its actions, even if a well was not drilled. The referenced APD was approved on 02/07/2012 and per BLM reinstatement letter (copy attached), final extension was granted to 6/24/2016. Furthermore, Hilcorp's 2019 Plan of Development for the San Juan 27-4 Unit does not list well for drilling operations. Therefore, APD is rescinded effective to date of this letter.

Under 43 CFR 3165.3 (b), you may request an Administrative Review of any instructions, orders, or decisions issued by the Authorized Officer. Such a request, including all supporting documents, must be filed in writing within 20 business days of receipt of this notice and must be filed with the State Director, Bureau of Land Management, P.O. Box 27115, Santa Fe, New Mexico 87502-0115. Such a request will not result in a suspension of the instructions, orders, or decisions unless the reviewing official determines. Procedures governing appeals from the instructions, orders, or decisions are contained in 43 CFR 3165.4 and 43 CFR 4.400 et. Seq.

By letter dated May 9 2014, you requested reinstatement of 12 Applications for Permit to Drill (APDs) for wells that were inadvertently rescinded due to an administrative oversight. You indicate that all of these wells are considered essential to commence an active drilling program here in the San Juan Basin.

After due consideration, the APDs on the attached list are hereby reinstated effective June 24, 2014. These APDs are now considered to be in full force and effect and have the remaining time before the original APD expiration or one full year, whichever is greater.
