In response to requests by the Farmington Field Office BLM and the NM OCD, and in keeping with the 5 year MIT requirement, Advanced Wireless Communications LLC intends to conduct a Mechanical Integrity Test (MIT) on the Dewey 2. Test will consist of pressuring up the wellbore to 500 psi and monitor the pressure for 30 minutes to one hour as requested by onsite BLM and/or OCD representative using a flow chart to monitor any and all pressure decreases during the allotted testing time.

The test will take place between the dates of May 13th and May 24th and between the hours of 8 AM and 4:30 PM. Exact date and time to be coordinated with the local BLM and NM OCD offices for most convenient witnessing times as needed.
