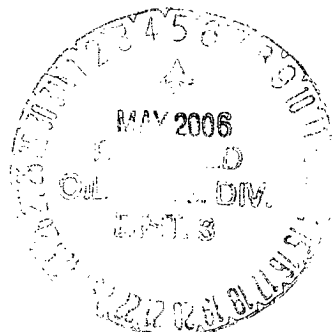

Plug down @ 9:45 on 04/19/06. Circulate 14 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
