Pumped 2475 gals 15% HCL w/5 gals corrosion inhibitor, 10 gals FSW-4807 (mutual solvent) & 5 gals Ferrocheck (iron chelant) down tbg. Flushed w/5 bbls Fresh Water to flush surface equipment (pumps and pump lines).

Pumped 73 bbls produced water down tbg.
Shut in well for 5 hrs.

Resumed salt water injection
