Recent attempts to produce well has been unsuccessful and uneconomic. A production verification test will be conducted 12 months from NOI approval and submitted for shut-in status to continue. Hilcorp Energy has a long term shut-in compliance agreement with NMOCD (ACOI-2017-003A).
