Cement (40% excess) as follows; pumped 10 bbls at 8.3 lbs of FW, followed by 40 bbls IntraGuard EZ II spacer at 11 lbs, followed by 496 sx (138 bbls) at 13.3 lbs, 1.56 yield, 7.70 gps. Displaced with 10 bbls retarder, 116 bbls biocide. Partial returns last 40 bbls of displacement. Land plug 100 FCP. Bump plug at 1600 psi. Check floats. Floats held. 1 bbl back on bleed off. TOC: 4949 BOC: 10819. RD BJ cement crew. 11/20/19: Install Cameron packoff. Test 5000 psi. Test good. ND BOP. Install wellcap. Rig release at 03:30.
