1. Pick up and remove all trash, metal, cable, and any foreign debris within 200' of location.
2. Remove anchors, if present.
3. Strip top soil. Push fill from east side of location to recreate natural contours with to silt traps, along with a ridge in the middle of location to divert water.
4. Rip compacted soil and walk down entire well pad.
5. Reclaim and fence access roads.
6. Install water bar on main road.
7. Re-seed all disturbed areas. Drill where applicable at 12lbs an acre, and broadcast seed and harrow, at 24lbs an acre, all other disturbed areas. Broadcast seed a double the rate of seed.

Wildlife Mix seed mix will be used.
