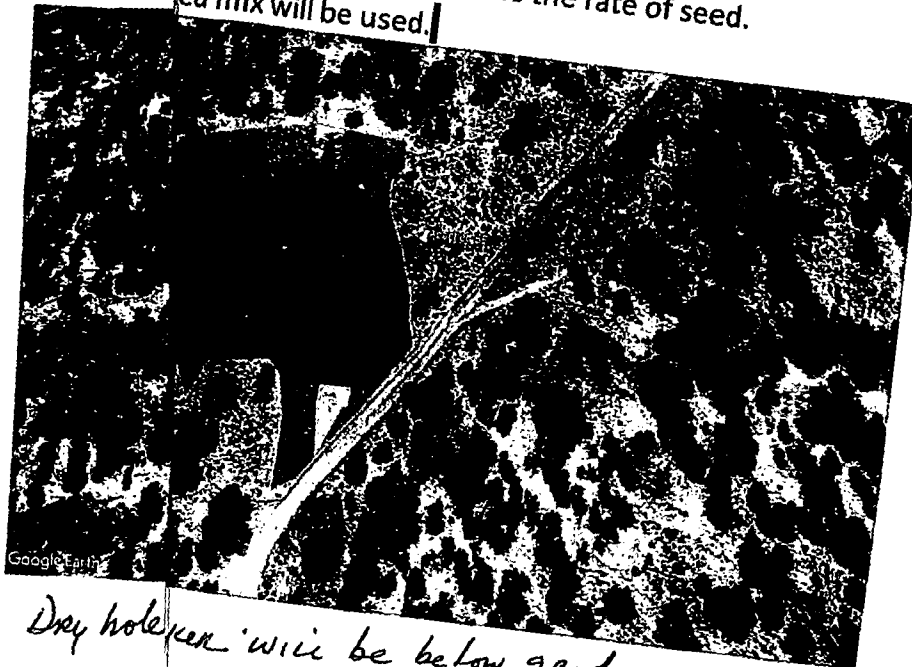

1. Pick up and remove all trash, metal, cable, and any foreign debris within 200' of location.
2. Disk and seed.
3. Re-seed all disturbed areas. Drill where applicable at 12lbs an acre, and broadcast seed and harrow, at 24lbs an acre, all other disturbed areas. Broadcast seed a double the rate of seed. Wildlife Mixed mix will be used.



4. Dry hole will be below grade.
