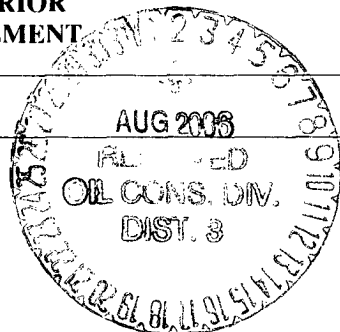

Pumped 10 bbls FW, pumped 68sxs (108cf - 19.2 bbl slurry) Type I-II Portland Cement w/20% Fly Ash. Dropped Plug & displaced with 13.8 BBL H2O. Circ. 3 bbls cement to surface. WOC, install wellhead, RDMO.
