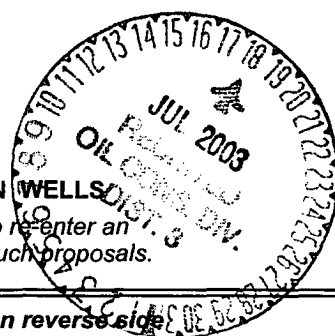

RU Halliburton to cement. Pumped a preflush of 30 bbls 2% KCL. then pumped 460 sx (668 cf - 119 bbl slurry) 50/50 STD POZ, 3% gel, 0.2% CFR-3, 0.1% HR-5, 0.8% HALAD-9, 5#/sx Pheno-seal. Dropped plug and displaced w/116 bbls 2% KCL. Plug down at 0629 hrs 7/13/03. No cement to surface, none planned. ND BOP, Set slips and cut off casing. RD & released rig. Will show casing PT and TOC on next report.
