13. Describe Proposed or Completed Operations

It is intended to remove the existing dual tubing configuration, add pay in the Mesaverde, and restimulate the Pictured Cliffs interval in the existing wellbore as follows:

Move in, rig up, pull tubing and packer configurations. Pressure test the casing. The Mesaverde will be selectively perforated and stimulated under a packer. The Mesaverde will then be isolated and the Pictured Cliffs interval restimulated. The wellbore will be cleaned out to PBTD. Both formations will be commingled using a single string of tubing. A down hole commingle application will be submitted.
