Fraced PC w/81,500# sand in 70Q slick foam. Cleaned out after frac & tested PC on 1/24/06 for 2 hrs on 1/4" chokefor 5 psi & 29 MCF/D & 2 BWPH. Set CIBP @ 3380'.

Perf FRTC @ 3552'-59' & 3562'-71' w/6-0.41" spf. Total 96 holes. Treated FRTC w/ total 3000 gal methanol & 1600 gal 10% Formic acid & N2. Tested FRTC on 2/1/06 on 1/4" choke for 60 psi for 2 hrs & 110 MCF/D. Landed 2-3/8" 4.7# J-55 tbg @ 3577'. Ran pump & rods. Completed as a single FRTC gas well with PC perfs below CIBP @ 3380'. Released rig 2/4/06.
