Moved in service unit and pulled production tubing and packer. Set CIBP above lower Dakota zone at 7960'.  
Ran production tubing and packer back in well and set 2-3/8" tubing at 7952' with Model "R" packer at 6141'.  
Will monitor Dakota water production and evaluate if further corrective action is needed.
