Set external casing style (open hole) packer inside 6.25" open hole wellbore at 5335' MD (2624' FSL, 1609' FWL). Spot 25 sks (100% true hole volume for 100 linear ft) cement on top of plug. Cement consisted of: Class G with 1.0% CaCl<sub>2</sub>, 0.20% Halad-344 mixed at 15.4 ppg. TOH and WOC for 8 hours. Tagged top of cement at 5300' MD (2590' FSL, 1608' FWL). TOH and run 4.25" uncemented liner.
