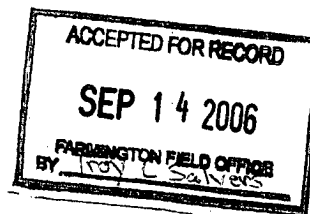

Circulate 35 bbls cement to surface. Plug down @ 2:00 pm on 09/10/06. RD Halliburton. ND BOP. Rig released 09/11/06. Will test production casing during completion.
