This well was spudded 5/25/06 and drilled to a TD of 1010' (See Sundry Notice dated August 15, 2006). The APD was approved 3/7/06 with 7" surface casing and 6-1/4" hole size drilling after surface casing was set. However, surface casing used for this well was 8-5/8" 24# J-55 ST&C, set @ 169', with continued drilling of 7-7/8" hole to TD. This error was an oversight on our part. We sent in several Sundry Notices for other approved wells (in the same area), changing the 7" casing (as shown on the approved APD's) to 8-5/8" csg, but we apparently missed this one. SG is belatedly requesting approval for the change in surface casing and size of borehole.
