Drilled 12 1/4" hole to 285' on 01/08/07, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 275'. Cemented w/200 sx (42 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 3,045' on 01/11/07, set 72 jts of 7", J-55 LT&C, 23# casing at 3,036'. Cemented lead w/550 sx (144 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (16 bbls) STD, 4/10% Halad 344. Circulated 30 bbls of cement to surface. Tested casing to 1500 psi.
