This well was completed in the Fruitland Coal Formation 8/8/06, and SG is in the process of obtaining BLM pipeline ROW's for sales. Due to the length of time before SG is able to put this well on line, SG is requesting approval to vent gas to the atmosphere for up to 30 days in order to evaluate anticipated production. Total volume vented will no where near exceed 50 MMCF. Any produced water will be trucked to an approved disposal facility.
