Due to high line pressure and low wellhead psi, a compressor must be installed on the above mentioned well. The following measures have been taken to limit sound from the compressor:

- 1) Installed insulated sound wall w/hospital grade silencer
- 2) Monitor noise for compliance

The compressor is a Caterpillar 3304, CIP 2-stage recip 65 hp. The nearest house is 0.27 miles.
