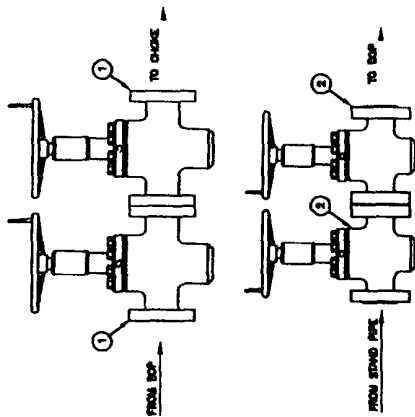

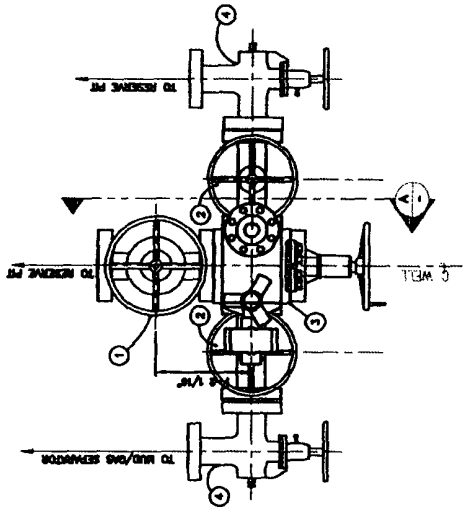

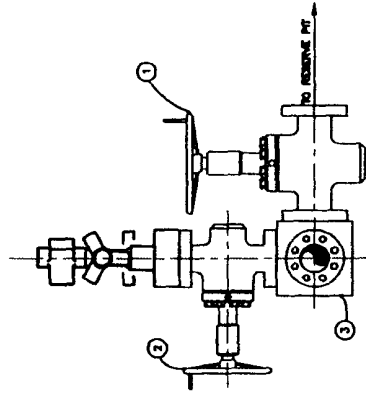


BOP SIDE OUTLET VALVES

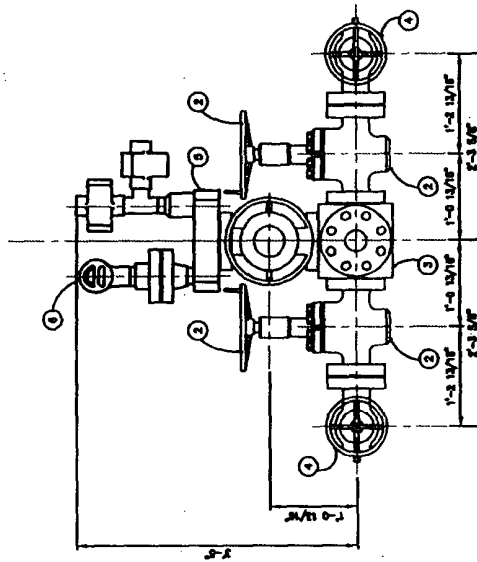


PLAN VIEW
