Drill to TD @ 1280' on 12/14/06. Run 5½" 15.5# J-55 csg in 7" hole. Land @ 1272', float collar @ 1232'. Cement w/75 sx Type 5 cement w/2% Lodense, 2# PhenoSeal/sx & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/2# PhenoSeal & 1/4# celloflake/sx (221 cu ft total slurry). Displace w/29 bbls water. Circulate 8 bbls cement. Pressure test will be reported on completion sundry.
