After initial cement job on 5-1/2" production string yielded no returns a CBL was run to identify TOC. Found TOC at 3170'. Shoot Squeeze holes at 3159' and set cement retainer at 3065'. Pumped 150 sx (31.5 bbls) "B" w/ 0.4% Halad 344 and 1% CaCl2 Well on vacuum when done pumping. Pressure test of casing after drilling out failed. Shot squeeze holes at 3158' and set cement retainer at 3097'. Pumped 220 sx (64 bbls) Foamed 50/50 Poz w/ 2% Gel, 0.2% Versaset, 0.1% Diacel LWL down backside. Pumped 3 bbls same slurry down backside as cap. After drilling out retainer, pressure test of squeeze holes failed, but casing above holes tested good. Pumped 50 sx (10 bbls) "B" w/ 0.4% Halad 344 and 2% CaCl2 under packer into squeeze holes with well on vacuum after pumping. Let cement set and pumped 2100 sx (21 bbls) same slurry w/ 800 psi after pumping. After drilling out pressure tested casing from PBDT to surface to 1000 psi- good test.
