Drilled 12 1/4" hole to 286' on 2/6/07, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 275'. Cemented w/200 sx (42 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. No cement to surface. Ran in hole with 1" top job pumping 40 sx (8 bbls) Class "B" STD cement and circulating 4 bbls to surface. Test casing to 750 psi.
