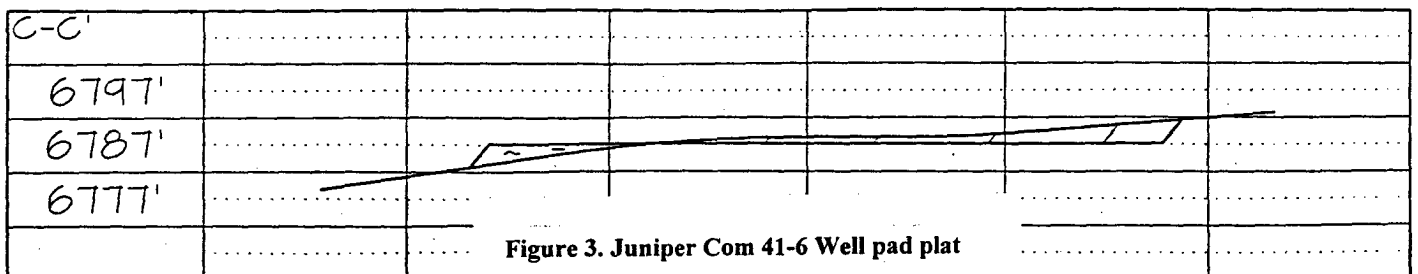
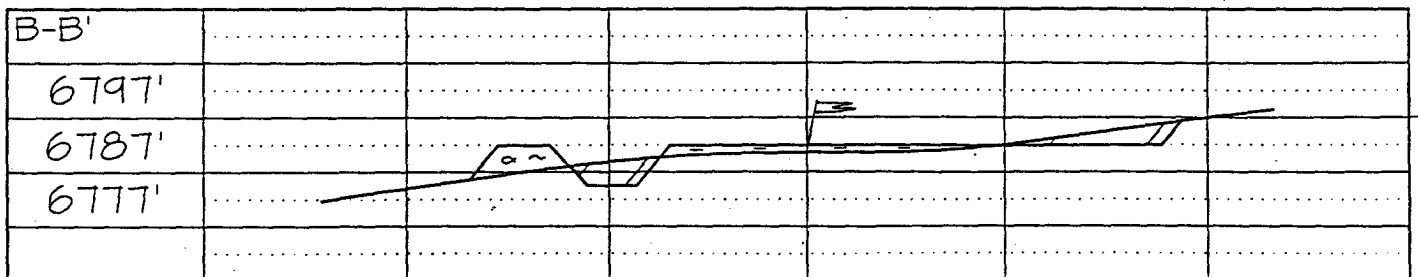
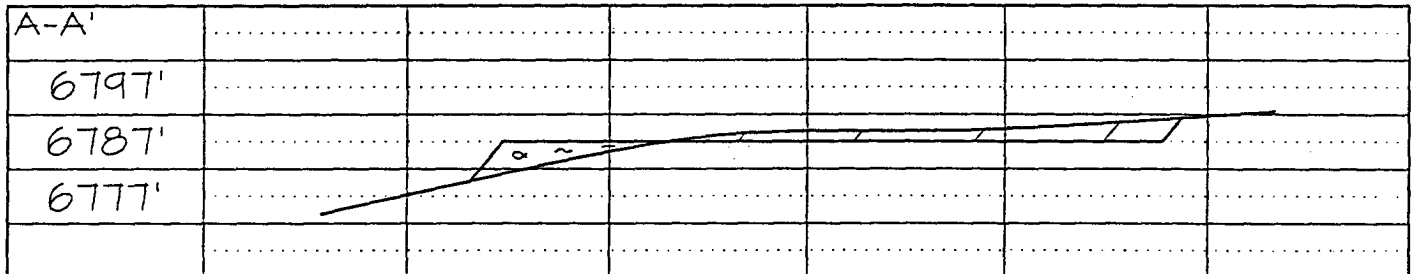
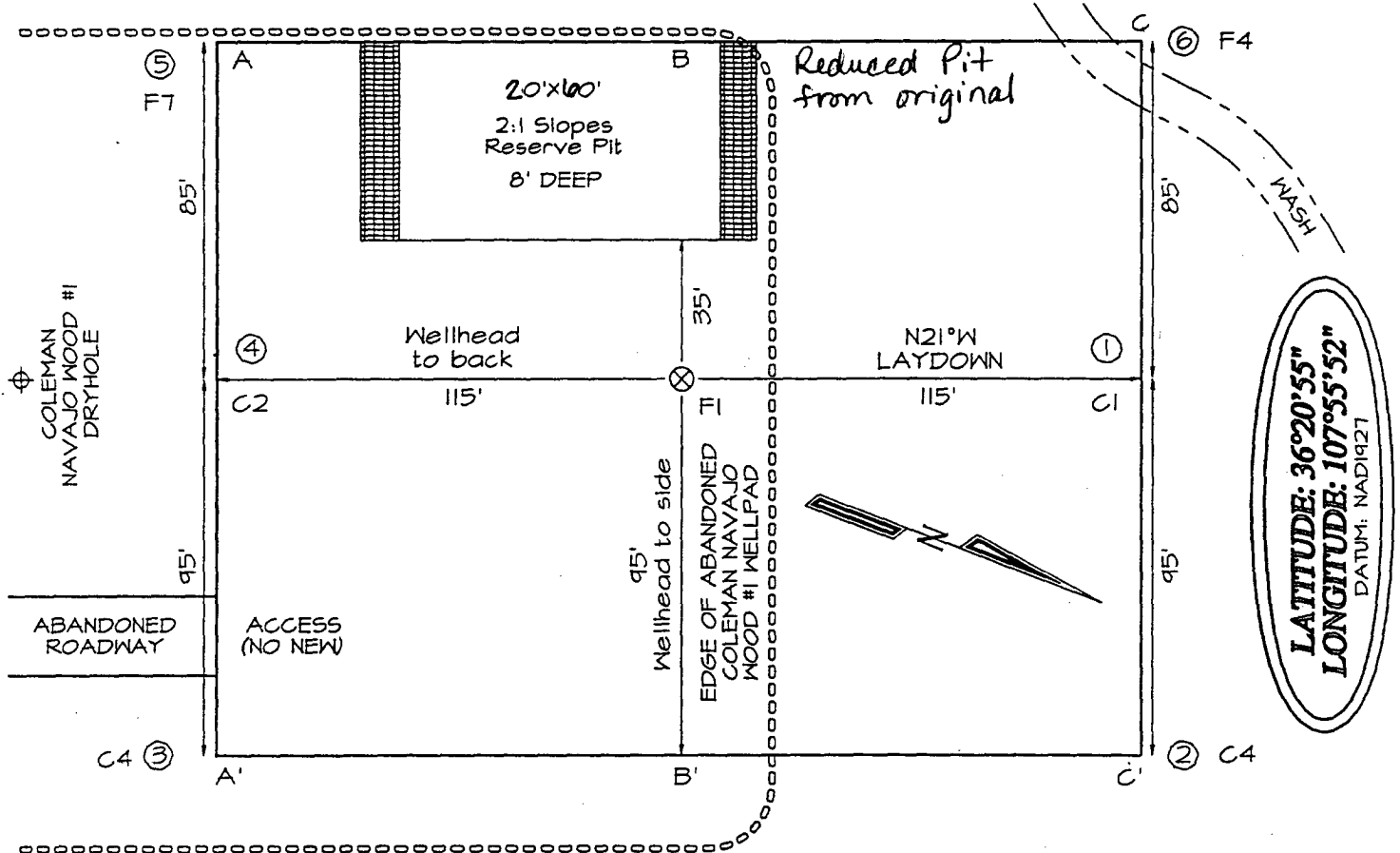


Figure 3. Juniper Com 41-6 Well pad plat
