Energen Resources would like to make changes to the casing strings on the Trading Post #1S well as follows:

Change the surface casing from a 7" 23 ppf to an 8 5/8", 24 ppf, J-55 STC and cement with 125 sks at the same set depth of 150'. The wellbore size will be increased to a 12 1/4" hole.

Change the production casing from a 4 1/2" 11.6 ppf to a 5 1/2", 15.5 ppf, J-55, LTC and cement with 150 sks tail and 175 sks lead at the same setting depth of 1406'. The wellbore size will be increased to a 7 7/8" hole.
