The packer was set @ 2110' to isolate the Basin DK and the Basin FC formations.

Note to NMOCD:

Patina San Juan, Inc. seeks an exception to NMOCD rule 19.15.3.112.C.1.b.

Patina is requesting a variance to the 100' rule for the packer depth. The well has been set up for a plunger lift system to aid in the optimization of production. By placing the packer as high as possible, the added volume in the annulus will help create the energy needed to lift the plunger during cycles. We believe that this type of operation will eliminate the necessity of having to vent the well to get the plunger to the surface.
