Drill to TD @ 1300' on 3/30/07. Run 5½" 15.5# J-55 csg in 7" hole. Land @ 1287', float collar @ 1247'. Cement w/75 sx Type 5 cement w/2% Lodense, 2# PhenoSeal & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/2# PhenoSeal & 1/4# celloflake/sx (220 cu ft total slurry). Displace w/30 bbls water. Circulate 7 bbls cement. Pressure test will be reported on completion sundry.
