Drilled 6 1/4" hole to 8,756' on 3/25/07, set 207 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,756' with a Hyd DV tool at 5,608'. Cemented 1st stage lead w/300 sz (78 bbls) 50/50 POZ "G" cement w/3% Gel, 0.9% Halad-9, 0.1% HR-5, 0.2% CFR-3, 5#/sz Gilsontite, 1/8#/sz Poleflake. Cemented 2nd stage lead w/350 sz (907 bbls) 50/50 POZ cement w/2% Gel, 0.2% Versaset, 0.1% Diacel LWL, tail w/57 sz (15 bbls) same slurry non-foamed. No cement to surface, top of cement is at 600' per CBL. Tested casing to 1500 psi, tested good.

Drilled out under 4 1/2" shoe for an open hole to 8,789' to look at Morrison. Will run CIB at 8,750' and dump 10' cement on top to plug off open hole.
