Tail w/105 sx (148 cf) Type III cmt w/2# pheno seal, 0.2% CD-32, 1/4# celoflake, & 1% CaCl2. Cmt locked up. Found top of cmt inside 5-1/2" csg @ 295'. Drilled out cmt from 295' to 4067' & pressure tested 5-1/2" csg to 1200 psi for 10 min.-OK.
