We propose to plug and abandon this well. We will clean out with 1" tubing to TD of 967'. Perforations are 946'-950'. We will plug with 5 sx cement from bottom up which will give about 250 feet of cement fill up. We will spot a 3 sx plug at 500 feet and 2 sx plug at surface with a dry-hole marker.
