Cemented 1st stage w/260 sx (68 bbls) 50/50 "G" POZ w/3% Gel, 9% Halad-9, .1% HR-5, .2% CFR-3. 5#/sx Gilsonite, and 1/8#/sx polyflake. Inflate ACP and open DV tool. Cement 2nd stage w/225 sx (56 bbls) 50/50 POZ "B", 3% Gel, 1% Halad 9, 2/10% CFR3, 5#/sx Gilsonite & 1/8#/sx Polyflake. Close DV tool, did not circulate cement to surface. Had full circulation throughout job. Tested casing to 1500 psi.
