Due to Phillips' work load and scheduling problems and the fact that this well is in the Big Game Closure area we were not able to complete the work planned for this well this year. Plans have also changed slightly, to running a cased log to evaluate the Dakota and the Mesaverde zones.

If the DK zones looks unproductive, then we will be TAing the Dakota interval of this well by cementing a 50' plug above the Dakota perforations and then completed this as a single MV recompletion as our previous sundry dated 5/11/01 stated. But if the DK looks as if there is potential, we will then try to restimulate the Dakota and then complete the MV interval as indicated on previous sundry and we will then file paperwork to commingle the DK/MV zones. All of this of course is contingent on this well passing the casing integrity test to be performed at the time of workover. Plans are to have this work started by August 1, 2002. We wish to use the C102 for the MV dedication that was attached to the 5/11/01 sundry.


