Broke down lower perfs 1334'-47' w/750 gal 7-1/2% HCL & upper perfs 1303'-10' w/750 gal 7-1/2% HCL. Fraced Tertiary perfs 1303'-47' w/65,640# 16/30 sand in 70 quality foam. Final well test for 3 hours on 9/27/07 on 1/2" choke for 25 psi & 250 MCF/D. Landed 2-3/8" 4.7# J-55 tbg @ 1324'. Released rig on 9/28/07. Completed as a single Tertiary gas well.
