Cemented 2nd stage with 440 sx Class HLC cement (12.4 ppg & 1.9 cuft/sx) f/b 100 sx Type G cement (15.6 ppg & 1.18 cuft/sx). Stage tool closes @ 2834 psi. Circ 20 bbls cement to surf. Finished cement job on 10/16/07.
