Drilled 12 1/4" hole to 299' on 5/19/05, set 13 jts of 9 5/8", H-40, ST&C, 32.3# casing at 299'. Cemented w/175 sx (36 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 0 bbls of cement to surface, top of cement at surface. Test casing to 1500 psi.

Drilled 6 1/4" hole to 3,535' on 7/25/05, set 83 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,530'. Cemented lead w/375 sx (98 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsolite & 1/4# Flolece. Circulated 60 bbls foamed cement to surface. Landed 2 3/8" production tubing at 3,425'.

On 8/9/07 2 3/8" tubing was run into the hole to a depth of 3,425'. ✓
