XTO Energy Inc. spudded 17-1/2" hole on 11/24/07 & drilled to 90' (cond TD). Set 13-3/8", 54.5#, J-55 conductor pipe @ 83' on 11/25/07 & cemented w/100 sx Type G cement (15.2 ppg & 1.18 cuft/sx). Circ 8 bbls cement to surf.

Drilled 12-1/4" hole to 860' (surf TD) on 11/28/07. Set 9-5/8", 36#, J-55 casing @ 855' on 11/30/07 & cemented w/500 sx Type V cement (15.6 ppg & 1.18 cuft/sx). Circ 20 bbls cement to surf. Pressure tested surf casing to 1500 psig for 30 min on 12/7/07. Tested OK.
