Elm Ridge Exploration Co, LLC spud this well on 3-10-08. We drilled a 12-1/4" hole to 385'. We ran 9 joints of 8-5/8" 24# J-55 casing to 378'. Pumped 320 sks of Type G cement w/ 2% CACL. Circulated 10 bbls of cement to surface. Pressure tested well to 1500 PSI for 30 plus minutes. Marko Kecman with the BLM was notified but not present to witness cement and casing job.
