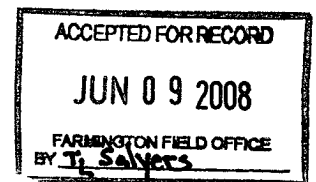

Ran pump and rods. Turned well over to production
