Elm Ridge Exploration spud the above well on 6-17-08, we drilled a 12 1/4" hole to 146' then ran 3 joints of 8 5/8" 24# J-55 Casing, casing landed at 141' KB. We then pumped in 100 sks of Type G cement with 2% cc and 1/8# polyflake, circulated 2 bbls of good cement to pit. Pressure tested well to 1500 PSI for 30 plus minutes. BLM was notified of job but not present to witness
