Tail w/50 sx Type 5 cement w/2#/sx PhenoSeal & 1/4# celloflake/sx (200 cu ft total slurry). Circulate 10 bbls cement. Wayne Smith Drilling rig released 7/25/08. Pressure test will be reported on completion sundry.
