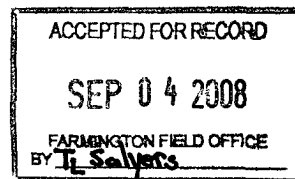

Drilled 6 1/4" hole to 3,515' TVD on 8/4/08. Underreamed hole to 9 1/2" from 3,281' to 3,515'. Utilized natural and air assisted surges to remove near wellbore material. On 8/21/08, set 7 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,514' with 0 sx of cement. Top of liner hanger is at 3,207'. Perforations are from 3,276' - 3,508', 4 SPF, 0.52", 336 holes, 120 degree phasing. On 8/22/08 ran in hole with 109 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,483'.
