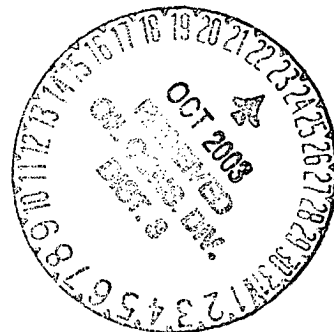

9-28-03 Circ hole clean. TIH w/72 jts 4 1/2" 10.5# J-55 ST&C csg, set @ 3140'. Pump 10 bbl calcium chloride wtr, 2 bbl wtr, 20 bbl flow-guard, 2 bbl wtr ahead. Cmt'd w/265 sx Class "B" Premium Lite cmt w/3% calcium chloride, 0.25 pps Celloflake, 5 pps LCM-1, 0.4% fluid loss, 0.4% sodium metasilicate (564 cu.ft.). Tailed w/90 sx Class "B" Type III cmt w/1% calcium chloride, 0.25 pps Celloflake, 0.2% fluid loss (124 cu.ft.). Displace w/wtr. Circ 49 bbl cmt to surface. WOC. PT 4 1/2" csg to 3800 psi/15 min, OK.
