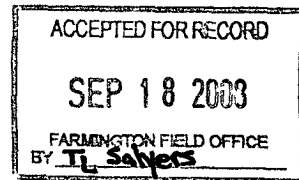

The 4 1/2" casing string is not cemented. Inflate all 5 packers and pull up to 70K, held ok. The rig was released on 9/9/08. ↓
