Maralex Resources, Inc., proposes to drill a vertical well at the above-designated location to test the Basin Fruitland Coal formation. A native mud will be used to drill the surface hole and produced water from Maralex's existing Fruitland wells will be used to drill the production hole. Both sets of casing will be cemented back to surface based on fluid and/or log calipers run at total depth.

The drilling contract has not been awarded yet, thus the BOP model to be used is not yet known. A typical model is shown on the attached page. Once out from under the surface casing, a minimum of 1,000 psi BOP and choke manifold system will be used. BOP controls will be installed before drilling the surface casing plug and used until the well is completed or abandoned.
