Pumped a preflush of 15 bbls FW w/dye in last 10 bbls. Pumped Lead - 540 sx (1409.4 cf - 251 bbls slurry) Class G, w/3% extender, 0.25#/sx Cellephane, 5#/sx Phenoseal, & 0.2% antifoam. Tail - pumped 180sx (228.6 cf - 40.7 bbls slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2.5#/sx Phenoseal, 2% BWOC CaCl₂, 0.25#/sx Cellophane, & 0.2% Antifoam. Released wiper plug & displaced w/82.5 bbls 2% Clay Stabilizer water. Bumped plug w/1511 psi. Circ. 90 bbls good cement to surface. ND BOP & set slips and cut off casing. Installed trash cap. RD & released rig @ 2130 hrs 6/20/03. Will show casing PT on next report.
