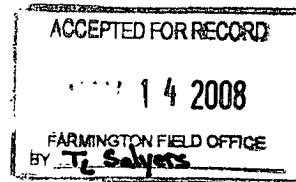

Drilled 12 1/4" hole to 314' on 8/28/08, set 15 jts of 20' each 9 5/8", H-40, ST&C, 32.3# casing at 308'. Cemented w/165 sx (34 bbls) Type 5 cement w/2% CaCl and 1/4# PSX Celloflake. Circulated 21 bbls of cement to surface. Test casing to 750 psi for 30 min. Held ok.
