- 3) RIH w/cement retainer & set same @ 2400'
- 4) Pump 59.5 cu ft (665') Class "B" cement & pull out of retainer
- 5) Dump 4.8 cu ft (53') Class "B" cement on top of retainer
- 6) Pressure test casing to 1500 psi, held
