

On 10/1/08, the 7" intermediate csg valve was blown resulting in a drop in the 5" production csg pressure. Devon plans to MI a workover rig, pull the tbq, set a BP above the MV perfs, locate the csg leak, & squeeze the leak as required. The cmt inside the 5" csg will then be drilled out to the BP & the csg leak pressure tested to 500 psi. Following a successful pressure test, the BP will then be drilled out, the well cleaned out to below the MV perfs, the production tbq run, & the well returned to production.
